Invitation for Bids

Supply and Delivery of Agriculture Home garden packages for 33 TICs in Stung Treng, Mondulkiri, Kratie and Ratanakiri
(Ref No. MAFF-G-40)

1. The Kingdom of Cambodia has received a credit from the *World Bank* toward the cost of *Land Allocation for Social and Economic Development Project III (LASED III)*, and it intends to apply part of the proceeds of this credit to payments under the Contract for *Supply and Delivery of Agriculture Home garden packages for 33 TICs in Stung Treng, Mondulkiri, Kratie and Ratanakiri, MAFF-G-40*.
2. The *Ministry of Agriculture, Forestry and Fisheries (MAFF)* now invites sealed bids from eligible and qualified bidders for *Supply and Delivery of Agriculture Home garden packages for 33 TICs in Stung Treng, Mondulkiri, Kratie and Ratanakiri, MAFF-G-40*.
3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of the *World Bank*.
4. This invitation is open to all bidders.
5. Interested eligible bidders may obtain further information from Land Allocation for Social and Economic Development Project III, Room No. 10 on the 1st Floor of the Agriculture Information & Documentation Centre (AIDOC) Building, Ministry of Agriculture, Forestry and Fisheries (MAFF), #200, Preah Norodom Boulevard, Phnom Penh, Cambodia. 6. Qualification requirements include:
 - The bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years of not less than 50% of the estimated value of the subject contract.
 - The bidder has completed contracts in the total cumulative amount equal to at least two times the estimated value of the subject contract in the preceding two years.
 - The bidder has availability of liquid assets through either: (i) access to a line of credit or cash in bank account of an amount at least 50% of the estimated value of subject contract; or (ii) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee USD 30.00 or its equivalent in Cambodian Riel being KHR 123,000.00. The method of payment will be Cash. The Bidding Documents may be collected in person at the discretion of the bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.
8. Bids must be delivered to the address given below at or before **12-June-2025 at 3:00 pm**. (Local Time) late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend in person at the address given below **on 12-June-2025 at 3:00 pm**. (Local Time)
9. All bids shall be accompanied by a Bid Securing Declaration as described in the Instructions to Bidders.
10. The Government and/or the Development Partner will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by them, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
