The Kingdom of Cambodia has received a Loan/Credit from the World Bank toward the cost of the Cambodia Land Allocation for Social and Economic Development Project (LASEDIII), and it intends to apply part of the proceeds of this Loan/Credit to payments under the Contract for *The Supply, Delivery and Installation of Net-House for SLC Site, Kbal Damrey Commune, Kratie Province, Contract Ref. No. MAFF-G-51*
2. The Cambodia Land Allocation for Social and Economic Development Project (LASEDIII) now invite sealed bids from eligible and qualified bidders for bidding of *The Supply, Delivery and Installation of Net-House for SLC Site, Kbal Damrey Commune, Kratie Province*, as described in section V.
3. Procurement will be conducted through **National Competitive Bidding** Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of *World Bank*.
4. This invitation is open to all *eligible bidders*.

6. Qualification requirements include:
 - (i.) The bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding 3 years (2022,2023,2024) of value not less than USD 198,825.00 per contract.
 - (ii.) The bidder has completed contracts in the total cumulative amount equal to at least USD 795,300.00 in the preceding two years.
 - (iii.) The bidder has availability of liquid assets through either: (i) access to a line of credit or cash in bank account of an amount at least USD 198,825.00 of contractual commitments; or (ii) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21
7. A complete set of Bidding Documents in **English Language** may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee **35 USD of each package**. The method of payment will be in cash or deposit to Bank Account No. **0000000013535**, Account Name: Ministry of Economy and Finance at National Bank of Cambodia. The Bidding Documents will be sent by airmail for delivery outside of Cambodia and by courier for local delivery or may be collected in person at the discretion of the bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.
8. Bids must be delivered to the address given below at or before 26 November 2025 at 10:00. (Local Time) late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend in person at the address given below on 26 November 2025, at 10:00. (Local Time)
9. All bids shall be accompanied by a Bid Securing Declaration as described in the Instructions to Bidders.
10. The Government and/or World Bank respectively, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive, or obstructive practices in competing for or in executing a contract.
