**Development of Storage Ponds in Prasneob SLC Site in Kampong Chhnang Province**

1. The *Kingdom of Cambodia* has received a Credit from the *World Bank* toward the cost of *Cambodia Land Allocation for Social and Economic Development Project (LASEDIII)*, and it intends to apply part of the proceeds of this Credit to payments under the contract named above.
2. The *Ministry of Agriculture, Forestry and Fisheries (MAFF)*, now invites sealed bids from eligible and qualified bidders for the *Development of Storage Ponds in Prasneob SLC Site in Kampong Chhnang Province*. The construction period is *twelve (12) months*.
3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/Programs.
4. This invitation is open to all qualified bidders from eligible source countries as described in the Bidding Document.
5. Bidders attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
  - Average Annual Construction Turnover: The average annual volume of construction work over the last 3 years (2021, 2022 and 2023) shall be: **USD 998,000.00**
  - Specific Similar Experience: Experience as prime contractor in the construction of at least two (2) Contracts for works of nature and complexity equivalent to the Works within the last 5 years: **USD 499,000.00** per contract.
  - Liquid Assets: The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be: **USD 167,000.00**
