**Invitation for Bids**

**For the Supply and Delivery of Agriculture Support Packages,  
Poy Char Commune, Phnom Srok Distric, Banteay Meanchey Province**

1. The Kingdom of Cambodia has received a Loan/Credit from the World Bank toward the cost of the Cambodia Land Allocation for Social and Economic Development Project (LASEDIII), and it intends to apply part of the proceeds of this Loan/Credit to payments under the Contract for Supply and Delivery of Agriculture Support Packages, Poy Char Commune, Phnom Srok Distric, Banteay Meanchey Province (Procurement No. **MAFF-G-26**).
2. The Cambodia Land Allocation for Social and Economic Development Project (LASEDIII) now invites sealed bids from eligible and qualified bidders for bidding of **the Supply and Delivery of Agriculture Support Packages** as described in section V.
3. Procurement will be conducted through **National Competitive Bidding** Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of *World Bank*.
4. This invitation is open to all *eligible bidders*.

6. Qualification requirements include:
  - (a) Copies of original documents defining the constitution or legal status, place of registration, and principal place of business evidencing legal status in an eligible source country as defined in GCC Sub-Clause 6.1
  - (b) In the case of a Bidder offering to supply goods under the contract which the Bidder did not manufacture or otherwise produce, the Bidder has been duly authorized by the goods' Manufacturer or producer to supply the goods in Cambodia;
  - (c) The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
    - (i) that the Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years of not less than the amount specified in the **BDS**.
    - (ii) that the Bidder has completed contracts in the total cumulative amount equal to at least the amount specified in the **BDS** in the preceding two years.
    - (iii) that the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.
    - (iv) that the Bidder has availability of liquid assets through either:



- a. access to a line of credit or cash in bank account of an amount at least the amount specified in the BDS, net of other contractual commitments; or
  - b. credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
7. A complete set of Bidding Documents in **English Language** may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee **35 USD of each package**. The method of payment will be in cash or deposit to Bank Account No. **000000013535**, Account Name: Ministry of Economy and Finance at National Bank of Cambodia. The Bidding Documents will be sent by airmail for delivery outside of Cambodia and by courier for local delivery or may be collected in person at the discretion of the bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.

The Kingdom of Cambodia and/or for the Work will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Royal Government of Cambodia and/or World Bank respectively, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive, or obstructive practices in competing for or in executing a contract.
