1. The Royal Government of Cambodia has received a loan from the World Bank for supporting the Land Allocation for Social and Economic Development Project III (LASED III). The project development objective is to provide access to land tenure security, agriculture and social services, and selected Infrastructure to small farmers and communities in the project areas.
2. The LASED III Project is now inviting eligible individual qualified applicants for National Operation and Coordination Consultant (MAFF-CS-54) for the LASEDIII project. The applicant is instructed to submit Letter of Expression of Interest (EOI) and detail CV by or before 20 March, 2025. In their Letter of Expression of Interest, the applicant must dedicate the preference target province they want to apply.
3. The following are the key qualification and experience requirement:
 - Minimum bachelor's degree in project management, business administration, policies and land management.
 - At least five-year progressive experience in implementation of projects in areas related to project coordination and management, rural/community development, land policy and rural land right issues;
 - At least five years in positions with project coordination and operation responsibilities with the international development partners, including the World Bank is an asset;
 - At least two-year in operations, good understanding of financial and procurement procedures, especially understand of SOP and the World Bank and/or UN's guidelines;
 - Experienced in working with the international development partners, including the World Bank is an asset;
 - At least two-years working experience in agriculture and social development, especially with SLC/ICLT related issues with government institutions, WB, UN and/or NGOs;
 - Experienced working with LASED Project, previously is an asset;
 - Proficient in report writing and spoken both in English and Khmer;
 - Adaptation to the working environment of the projects and able to travel to target provinces.
