Contract Duration: 24 months with possible to extend upon the satisfactory of the performance evaluation, and subject to the availability of the project budget.

1. The Royal Government of Cambodia has received a loan from the World Bank for supporting the Land Allocation for Social and Economic Development Project III (LASED III). The project development objective is to provide access to land tenure security, agriculture and social services, and selected Infrastructure to small farmers and communities in the project areas. The project now is intended to apply part of loan to proceed for the selection of the above consultancy services.
1. The MAFF/LASED III Project is now inviting eligible qualified individual applicants for the eight (8) positions of **Agriculture Development Facilitators (ADF)** for the LASEDIII project. The applicant is instructed to submit Letter of Expression of Interest (EOI) and detail CV by or before **18 November, 2024**. In their Letter of Expression of Interest, the applicant must dedicate the preference target province they want to apply.

 - Experience working with landless and land poor people and vulnerable groups in rural areas in enhancing the livelihood improvement;

 - Good of English communication skills, written and spoken.
 - Availability and willingness to undertake visits to the target communes.
