Invitation for Bids

The Supply, Delivery of Agricultural Support Kits and Installation Net Houses, and Chicken Cages to 12 Vulnerable Communities in Kampot, Kep, and Preah Sihanouk Provinces

1. The Kingdom of Cambodia has received a Loan/Credit from the World Bank toward the cost of the Cambodia Land Allocation for Social and Economic Development Project (LASEDIII), and it intends to apply part of the proceeds of this Loan/Credit to payments under the Contract for The Supply, Delivery of Agricultural Support Kits and Installation Net Houses, and Chicken Cages to 12 Vulnerable Communities in Kampot, Kep, and Preah Sihanouk Provinces, (Procurement No. MAFF-G-53).
 - a. Lot 1: The Supply, Delivery of Agricultural Support Kits to 12 Vulnerable Communities in Kampot, Kep, and Preah Sihanouk Provinces.
 - b. Lot 2: The Supply, Delivery and Installation Net Houses to 12 Vulnerable Communities in Kampot, Kep, and Preah Sihanouk Provinces.
 - c. Lot 3: The Supply, Delivery and Installation of Chicken Cages to 12 Vulnerable Communities in Kampot, Kep, and Preah Sihanouk Provinces.
2. The Cambodia Land Allocation for Social and Economic Development Project (LASEDIII) now invite sealed bids from eligible and qualified bidders for bidding of **The Supply, Delivery of Agricultural Support Kits and Installation Net Houses, and Chicken Cages to 12 Vulnerable Communities in Kampot, Kep, and Preah Sihanouk Provinces** as described in section V.
3. Procurement will be conducted through **National Competitive Bidding** Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of *World Bank*.
4. This invitation is open to all **eligible bidders**.

 - (i.) The bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years (2023, 2024 and 2025) of not less than:
-Lot 1: USD 30,800.00 per contract -Lot 2: USD 72,500.00 per contract -Lot 3: USD 356,850.00 per contract
 - (ii.) The bidder has completed contracts in the total cumulative amount equal to at least:
-Lot 1: USD 123,200.00 in the preceding two years -Lot 2: USD 290,000.00 in the preceding two years
-Lot 3: USD 1,427,400.00 in the preceding two years
 - (iii.) The bidder has availability of liquid assets through either: (i) access to a line of credit or cash in bank account of an amount at least: -Lot 1: USD 30,800.00 per contract -Lot 2: USD 72,500.00 per contract -Lot 3: USD 356,850.00 per contract or (ii) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.

The Kingdom of Cambodia and/or for the Work will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Royal Government of Cambodia and/or World Bank respectively, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive, or obstructive practices in competing for or in executing a contract.
