INVITATION TO BID

Wishes to engage a contractor to execute the following Works:
Agriculture Land Preparation
Plowing and Levelling in Poy Char SLC,
Poy Char Commune, Phnom Srok District, Banteay Meanchey Province

1. The Kingdom of Cambodia has received a Loan/Credit from the World Bank toward the cost of the Cambodia Land Allocation for Social and Economic Development Project (LASEDIII), and it intends to apply part of the proceeds of this Loan/Credit to payments under the Contract of Land Preparation for Agriculture, Plowing and Levelling in Poy Char SLC, Poy Char Commune, Phnom Srok District, Banteay Meanchey Province (Ref No. MAFF-W-03)
2. Plowing and Levelling is scheduled to begin on first Eighth week of February, 2025 and completed by end of fourth week of April 2025.
3. Interested qualified eligible contractors are invited to obtain a copy of the bidding documents free of charge from the address given below.
4. To be considered qualified a contractor must:
 - (a) Have completed at least two contracts of similar works in the preceding 3 years of a value not less than USD 70,000.00
 - (b) Have completed contracts with a total cumulative construction turnover in the preceding two years equal to at least 140,000.00
 - (c) The proposed works manager must have at least 3 years of experience in the supervision of works of an equivalent nature and size and no less than one year as a manager.
 - (d) Submit documentary evidence to demonstrate the bidder's qualifications.
5. Quotations must be delivered to the address given below on or before *08. Jan. 2025* at 3:00 pm. (Local time), Late Quotations will be rejected. Quotations will be opened in public immediately thereafter at the same address in the presence of the Bidders' representatives.
6. The Employer shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated quotation and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
7. All quotations must be accompanied by a performance securing declaration as described in the bidding documents. Any quotation not accompanied by one will be rejected as non-responsive.
