Development of Agricultural Water Storage Ponds in Poy Char SLC Site in Banteay Meanchey Province

1. The Kingdom of Cambodia has received a Credit from the World Bank toward the cost of Land Allocation for Social and Economic Development Project III (LASED III), and it intends to apply part of the proceeds of this Credit to payments under the contract named above.
2. The Ministry of Agriculture, Forestry and Fisheries (MAFF), now invites sealed bids from eligible and qualified bidders for the Development of Agricultural Water Storage Ponds in Poy Char SLC Site in Banteay Meanchey Province. The construction period is seven (07) months.
3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/Programs.
4. This invitation is open to all qualified bidders from eligible source countries as described in the Bidding Document.
5. Bidders attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
 - Average Annual Construction Turnover: The average annual volume of construction work over the last 3 years (2022, 2023 and 2024) shall be: **USD 1,860,000.00**.
 - Specific Similar Experience: Experience as prime contractor in the construction of at least two (2) Contracts for works of nature and complexity equivalent to the Works within the last 5 years: **USD 930,000.00** per contract.
 - Liquid Assets: The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be: **USD 532,000.00**.
